Event Attendance Terms and Conditions

1. Use of mobile phones/pagers at the venue is not permitted (and must be turned off or silenced) other than within the designated permitted areas, by volunteers and officials working at the Event and for persons specifically authorized by IMG. You agree to comply with all notices at the venue and all directions from IMG, including directions from course marshals in relation to silence whilst players hit, the roped areas and other matters. You may be removed from the venue if you do not comply with any direction from IMG or its representatives. Your co-operation is greatly appreciated.
2. You are responsible for your accreditation. If your accreditation is lost, stolen or damaged you must immediately seek a replacement at the official Event Office.
3. You understand that the layout of the venue may be unfamiliar to you, so you must take care at all times. You acknowledge that you are responsible for your own safety. You enter the venue at your own risk. IMG advises that due to the uneven and, in parts, steep terrain of this course it may at times be difficult for you to move around freely and easily, and as a result it may not be suitable for your attendance if you suffer from certain medical conditions. You are advised to wear suitable footwear and to be careful in moving around the golf course.
4. You assume all risk and danger incidental to the game of golf and the risks involved with working at a golf tournament, and to the extent permitted by law you release the PGA Tour and its subsidiaries, IMG (including their directors, officers, employees, consultants, contractors, agents and other volunteers), the host broadcaster, all of their sponsors, participating players and all of their agents from any liability for any damage, loss, liability or injury you may suffer in relation to your role and attendance at the Event and the assumption of such risk and danger howsoever caused including without limitation being struck by a golf ball or due to any negligence or other act or omission of IMG or its representatives, agents, contractors and/or other volunteers. You agree to compensate IMG for any damage, loss, liability or injury IMG may suffer as a result of your wilful, reckless or negligent acts or omissions at the Event.
5. You grant permission to IMG and the PGA Tour and their licensees to use your image or likeness in relation to any live or recorded television or other media transmission or reproduction in whole or in part of the Event.
6. No cameras, video or audio equipments, PDA's, radios, televisions, large eskies, stepladders, signs, banners, firearms, explosive devices, etc will be permitted on the grounds of the Event. You agree not to transmit or facilitate transmission of any account, description, picture or reproduction of the Event other than for private domestic purposes (that is, you cannot sell, license, broadcast, publish or otherwise commercially exploit them) without the written consent of IMG and the PGA Tour. In particular you may not make available any moving footage, sound recordings or series of still pictures taken at the Event on the internet or to mobile devices via mobile wireless technology.
7. No alcoholic beverages or glass bottles may be brought into or taken from the grounds of the Event. Only sealed plastic bottles may be brought into the grounds of the Event. Pets are not permitted within the grounds of the Event.
8. You are responsible for your own property whilst at the venue.
9. Soliciting autographs from Event players is prohibited. You agree that you shall not seek autographs from Event players, and you shall not pay another person to obtain an autograph for you. The sale of any autograph obtained by you is also prohibited.
10. You hereby consent to the reasonable inspection of your person and property before entering the Event, which inspection may include, without limitation, metal detection.
11. Your accreditation must be surrendered to IMG (and you may be removed from, or refused access to, the grounds of the Event) if, in the opinion of IMG (who shall at all times act reasonably in the exercise of its discretion), your behaviour is, or could be considered to be dangerous, offensive, a nuisance or annoyance to others, for example, if you appear to be under the influence of alcohol and/or drugs and/or are acting aggressively, or if you fail to obey any conditions of use, posted signs or instructions of Event officials, marshals and/or security personnel including, without limitation, any verbal or written instructions or prohibition on the use of mobile telephones/pagers, other electronic communication equipment, cameras, video, sound or image recorders and/or global positioning systems or similar positioning, tracking or measurement devices.
12. IMG may refuse you entry into, or remove you from, the venue if you do not obey these terms and conditions, or you interfere with the enjoyment, comfort or safety of other persons at the Event, you have lost, stolen, counterfeit, damaged or unreadable accreditation or you have acquired your accreditation from an unauthorised source, or IMG reasonably suspects you of any of the above.
13. These attendance terms and conditions may be supplemented by additional terms and conditions displayed at the venue.
